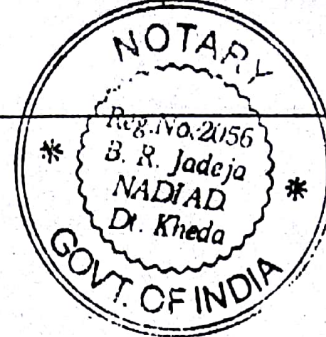

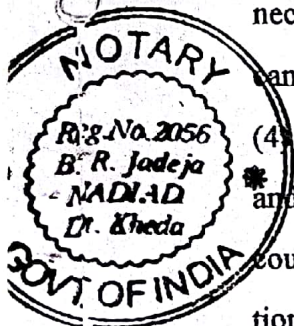
(3) Jurisdiction :-



The jurisdiction of this trust shall remain for Gujrat State at present. But if found necessary in future, after making resolution by majority, the scope of jurisdiction of the trust can be extended and can be curtailed also.

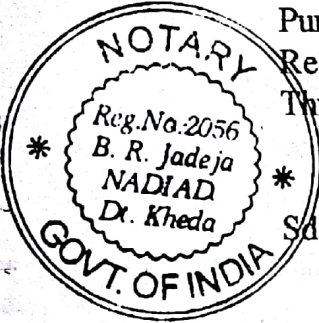

(2) To establish Hostels, Gurukuls, workshop - temple, cultural- exhibition Hall, etc, to run, to maintain and to do works in respect thereof as well as to run such running hostels, Gurukuls, and to take care of.

(3) To give books, notebooks, scholarship, term fees and other fees etc. to the students.

(4) To establish, to take care of, to run, to maintain, reading, rooms, libraries.

(5) To run adult education classes, other classes of education.

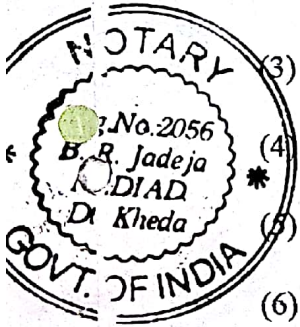
(6) To make help of clothes and other aids, to the students.

(7) To make monetary help to any public institution doing activities in respect of education as well as to make help in any other way.

(8) To do various activities like sanskrit - knowledge, music, sport, yoga, sadhana.

(9) To run Gaushala, and for its maintenance to purchase agriculture and implements, of agriculture. to make development of research work in Gaushala buffalo and agriculture and to give encouragement to institution doing such activities to give and to take aid.

(10) can purchase vehicles like motors, two-wheelers vehicles, tractors, etc. If found proper and necessary for the development of the institution and can sell the same.



- (11) To run free boarding places for poor and needy for the same to render medical physician help to monitarily needy person sick, back ward class person and to give aid in cash for meeting treatnent expenses.

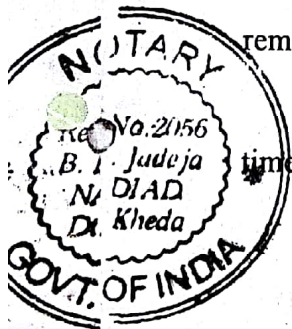
The minimum number of the trustees of this trust, shall remain five and maximum shall remain eleven.

The managing trustee shall have power to appoint trustees on the remaining post subject to the limitation of the maximum number in future by majority as well as to appoint proper and fit person on the post which would fall vacant of any trustee or trustees due to circumstance.

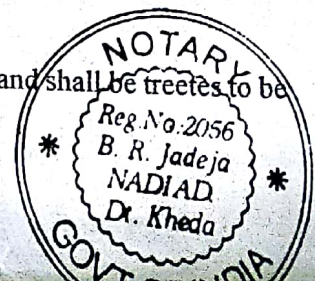
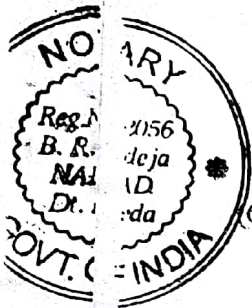
Shastri Harijivandasji shall remain as life-time managing trustee in this instritution. The managing trustee shall appoint the successor managing trustee by making written document out of sadhus of his Mandal during his life-time and the said appointment shall remain binding to all the trustees.

The managing trustees who would come of this instritution, shall have right to appoint his



on rent, shall give on rent, and shall give on lease, shall give way of gift and if necessary can also sale. The land of the building, in short, the arrangement, use or transaction of any sort in respect of immoveable property, can be made subject to the existing laws.

- (3) For the administration and development of the institution under its direction the trust shall frame proper bye-laws, and shall make change therein and make addition alteration or deletion, as well as if necessary can also cancel such framed rules and can also frame again new rules.
- (4) shall make appointment, promotion, transfer, dismissal, of the employees, transfer, dismissal, of the employees of the trust and the institutions under its direction, shall fix salary and also the pension, and in short can frame any rules touching the employment.
- (5) The trustees of this trust shall not take remuneration of any sort for the work done by them of the trust, under their designation, but shall make the expenses of the conveyance bus-fare, and any other traveling fare, expenses borne by them for going but and other places in respect of the works of the trust. The trust shall bear all the expenses of the persons giving honorary services in this trust.
- (6) The trustees if found proper can accept donation in consonance with the objects of the trust.
- (7) The resolutions and decisions in by majority and at any time if the votes of the trustees are even then managing trustee can give casting vote, There days notice shall be required to be given for convening the meeting of special work can be called by one day's notice.
- (8) The minutes book shall be kept of the proceedings taken place, in the meeting of the Trustee- Mandal.
- (9) The trustees can take money on loan for the works of the trust, If necessary subject to the existing laws.
- (10) The trustees if necessary can appoint sub-committees, and can also make change therein. As well as can also cancel such committee.
- (11) Trustees if necessary. can also make resolution by circulars.
- (12) Trustees can do any work for as administration, and direction and necessity of this institution.
- (13) The accounts of this trust shall have to be kept regular.
- (14) The account year of their trust shall commence from first April and shall be required to be completed on thirty first March.



The trustee board shall approve. Annuse but get it this trust before, (First) 18th April.

(15) Any work of this, trust shall be treated to have been done by the trustee in good faith & in all benagindes. In spite of that, in any damage, or loss is cause to the trustes-trust as a rasult fo the cheating committed by employees servents or agents brokers, for that there shall not be any personal liability of the trustees and the loss or damage count shall be required to be made good from the trust

(16) If the managing trustee of this trust shall remain present in the meeting of mandal, he shall take the seat as a president of the meeting, of due to circumstance, he could not remain present in the meeting, then , president shall take over the seat of president of the meeting.

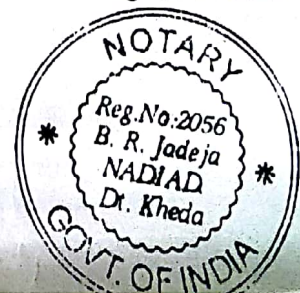
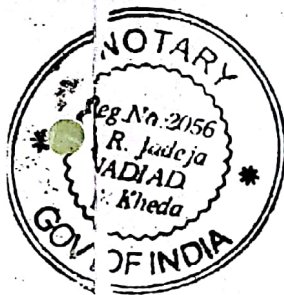
(17) Auditors of the trust :-

trustee mandal can appoint legal advisers for the problems of the laws which was arise in day to day administrations of this trust. of and when any legal problem arise against institutions made direction of this trust and the trustee of this trust and for that cases required to befiled, for conducting the cases as per legal advise of the legal adviser. advocates can be appointed and engaged and fix their remuneration can pay and disputes the same to them. of any change is required to be made in this trust deed such change can be effected by 2/3 majority (two third majority) or total trustee subject to raisting laws in force

Of and when the trustee of trust are not able to carry on any sort of activities, in that case, the property be entered to shri Gopinathgi Dev, Gadhpur or to public institution by majority, which would be decided by resolution by trustee mandal, I have accepted trust deed willingly and in complete sense and carefully, with full understanding which shall remain binding to me and my gurubhai and followers

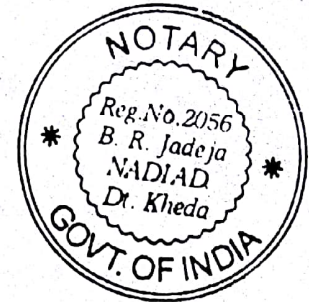

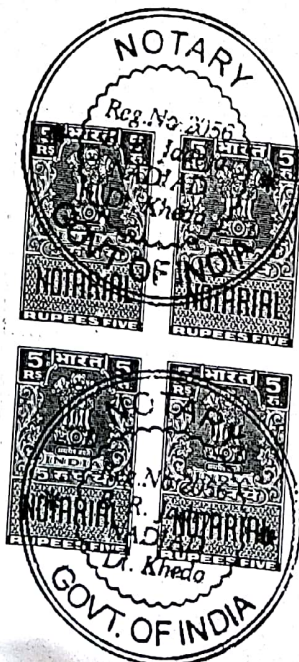
